

**Whirlpool® x OLIPOP® Sweepstakes
Official Rules**

1. **ELIGIBILITY:** The Whirlpool® x OLIPOP® Sweepstakes (the "Sweepstakes") is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees, officers and directors of Whirlpool Corporation and Olipop, Inc. (collectively, "Sponsor"), Ketchum Inc., Realtime Media LLC ("Administrator"), and their respective parent companies, affiliates, subsidiaries, advertising, promotion, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), and each of their immediate family members and those living in the same household of each (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, "immediate family members" are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, regardless of where they reside, and "those living in the same household" shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Non-winning entries received during Entry Period 1 will not roll over into Entry Period 2. The designated computer clock of the Administrator is the official time-keeping device for the Sweepstakes.

Upon successful submission of the registration form in accordance with these Official Rules, you will receive one (1) entry (an "Entry") into the applicable Entry Period. For purposes of this Sweepstakes, an "Entry" is defined as one (1) eligible registration received by Sponsor in accordance with these Official Rules. Entries must be successfully submitted through the Website during the applicable Entry Period. Entries not actually received by Sponsor will not

be entered into the Sweepstakes. Entries are subject to the limits set forth below. Entries received during an Entry Period will be eligible only for the drawing applicable to that Entry Period. Non-winning Entries received during Entry Period 1 will not carry over or otherwise be eligible for the Entry Period 2 drawing.
